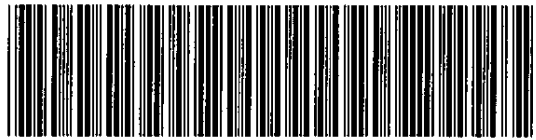

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

ARDOHM, INC.

The principal place of business of this corporation shall be 1814 Cove Point Road, Port Orange, Florida 32128, and the mailing address shall be 1814 Cove Point Road, Port Orange, Volusia County, Florida 32128.

ARTICLE II. NATURE OF BUSINESS




