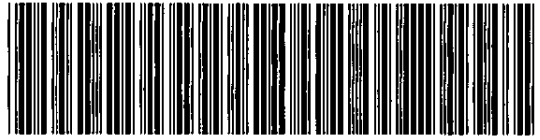

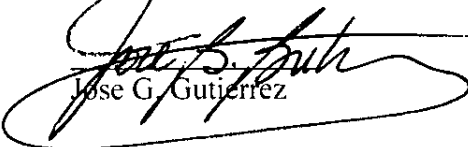

ARTICLE I: The name of the Corporation is the Antonio 20H Corporation.

ARTICLE VII: Meetings of the Shareholders may be held within or outside the State of Florida as the by-laws may provide:

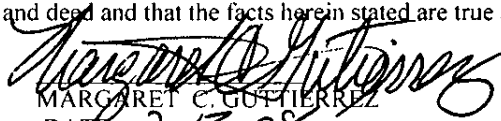

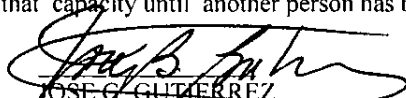
