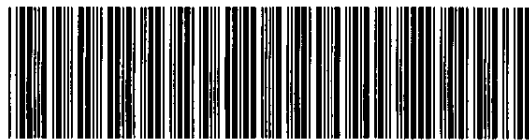

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: **CARAGAN CONSULTING GROUP, INC.**

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: EXISTENCE AND DURATION

This corporation shall exist perpetually commencing on February 15, 2008.

ARTICLE IV: PURPOSE

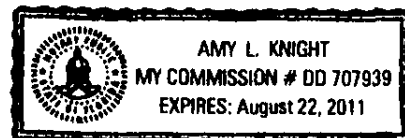
