ARTICLES OF INCORPORATION OF

The undersigned, acting as Incorporator of a corporation (the "Corporation") under the laws of the State of Florida as contained in the "Florida Business Corporation Act", Chapter 607 of the Florida Statutes, as amended, does hereby adopt the following Articles of Incorporation for the Corporation:

- 1. The name of the Corporation is: **ZUCCARELLI'S ITALIAN FOODS, INC.**

- 3. The Corporation shall have perpetual existence.


