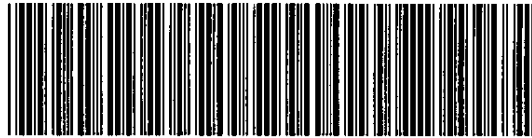

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

NAME: The name of this corporation shall be: DINNERWARE 2Go, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business of this corporation is located at 2011 Hollywood Drive, Leesburg, Florida 34748. The mailing address of the corporation is 2011 Hollywood Drive, Leesburg, Florida 34748.

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is to engage in the business of product sales, as permitted under the laws of the United States and the State of Florida.

This corporation shall have a president, who shall be a director, a secretary, and a

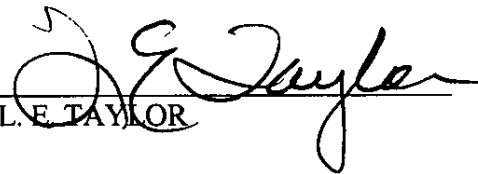

ARTICLE X. INDEMNIFICATION

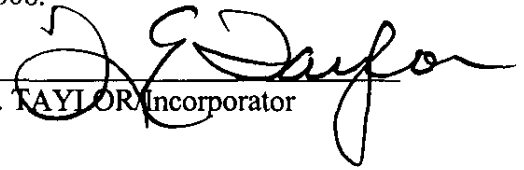
The corporation shall indemnify any officer or director, or any former officer or
