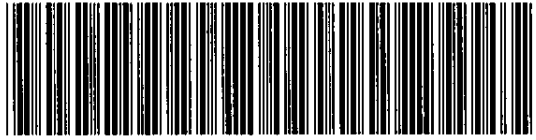

Running Wild, Inc, A Florida Corporation

**Article I:** The corporate name shall be **Running Wild, Inc.** and is formed on February 20, 2008. The corporation has elected to be taxed as an S corporation according to Federal Tax laws.

All common shares shall be identical with each other in every respect and the holders of common stock will be entitled to one vote for each share on all matters on which shareholders have the right to vote.
