ARTICLES OF INCORPORATION OF DARDEN SV, INC.

The undersigned, for the purpose of organizing a corporation pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

Article I. - Name

The name of this corporation shall be Darden SV, Inc. (the "Corporation") and its principal place of business shall be located at 5900 Lake Ellenor Drive, Orlando, Florida 32809.

Article II - Commencement of Corporate Existence

This Corporation shall commence corporate existence on the date of signing these Articles of Incorporation by the incorporator, and shall have perpetual existence unless sooner dissolved according to law.

Article III - General Purpose; General Powers

The general purpose of this Corporation shall be the transaction of any and all lawful business. This Corporation shall have all the powers enumerated in the Florida Business Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

Article IV - Capital Stock

This Corporation is authorized to issue 1,000 shares of voting common stock having no par value.

1. Voting Rights.

The holders of common stock shall possess and exercise exclusive voting rights and, at all meetings of the sharcholders, each record holder of such stock shall be entitled to one vote for each sharc held. All or a designated voting group of shareholders are entitled to cumulate their votes for directors.

Consideration for Issuance of Stock. The Board of Directors of the Corporation may from time to time issue the authorized stock of the Corporation, or any part thereof, for such consideration as it may deem equivalent to or in excess of the par value thereof. The authorized stock of the Corporation may be paid for, in whole or in part, in cash, promissory notes or other property, tangible or intangible, or in labor or services actually performed for the Corporation at a fair valuation placed on such property or services by the Board of Directors. Future services evidenced by a written agreement may constitute payment or part payment for the issuance of stock of the Corporation.

Article V - Initial Registered Office and Agent

The initial registered office of this Corporation shall be located at 11380 Prosperity Farms Road #221E, Palm Beach Gardens, Florida 33410, and the initial registered agent of this Corporation at that address shall be Corporate Creations Network Inc. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

Article VI - Initial Board of Directors

This Corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the bylaws, provided, however, that the number of directors shall never be less than one (1). Article VII - Incorporator

The Board of Directors shall have the power to adopt, alter, amend or repeal the bylaws of the Corporation, except as otherwise restricted by applicable law.

Article IX - Indemnification

The Corporation shall have all the powers and authority now or hereafter granted or permitted by law with respect to indemnification of directors, officers, employees and agents, and former directors, officers, employees and agents.

Article X - Amendment

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

Article XI - Headings and Captions

The headings or captions of these various articles of incorporation are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
