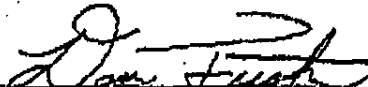
ARTICLE VII - INDEMNIFICATION

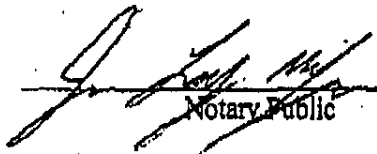

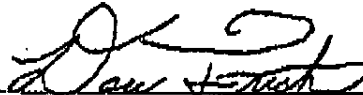

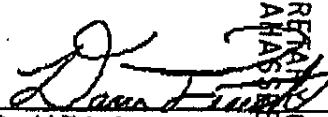
