ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

The name of this Corporation is **ZILER CUSTOM HOMES, INC.** The principal office, if known, or the mailing address of the Corporation is **10431 Little Horse Drive, Leesburg, Florida 34788**.

ARTICLE II - DURATION
