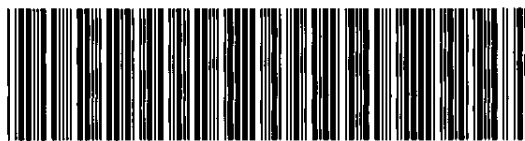

**ARTICLES OF INCORPORATION
FLORIDIAN CUSTODIAL SERVICES, INC.**

The undersigned Incorporator of Floridian Custodial Services, Inc., hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be Floridian Custodial Services, Inc. ("Corporation"). Its initial place of business shall be 5599 South University Drive, Davie, Florida 33607.

ARTICLE II

The general nature of the business to be transacted by the Corporation shall be that of any business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III

The total number of shares authorized to be issued by the Corporation shall be 10,000,000. Of such shares, 9,000,000 shall be common stock, \$0.01 par value and 1,000,000 shall be undesignated preferred stock.

ARTICLE IV

The term for which said Corporation shall exist shall be perpetual.

ARTICLE V

The number of directors shall not be fewer than one. A majority of the full board of directors or of the shareholders may, at any time during the year following the annual meeting of shareholders, increase the number of directors by not more than two directors, and appoint persons to fill resulting vacancies. The initial size of the Board of Directors shall be three and its members shall be: Jeffrey L. Leggett, Hugo A. Rivera and David M. Zinn.

ARTICLE VI

The officers of the Corporation shall be a President and any other officers as may be established by the Board of Directors from time to time. The initial President shall be Jeffrey L. Leggett.
