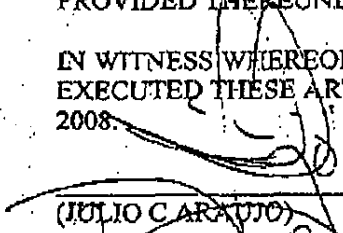
AMENDMENT

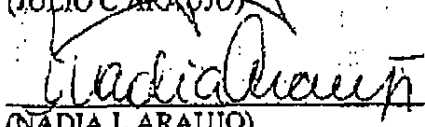

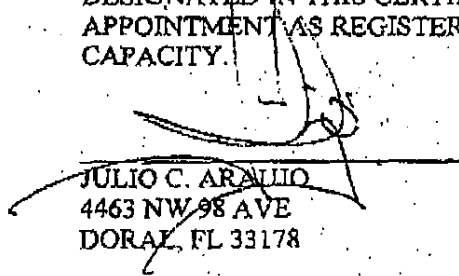
