ARTICLES OF INCORPORATION OF
teaspoon farms, inc.

The undersigned incorporator, SCOTT A. REMINGTON, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is teaspoon farms, inc.

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of the corporation is 125 W. Romana Street, Suite 800, Pensacola, Florida 32502, and the mailing address is Post Office Box 13010, Pensacola, Florida 32591-3010.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

The date for commencement of this corporation's existence shall be the date these Articles of Incorporation are filed with the Florida Secretary of State.


ARTICLE X - AMENDMENT
