

# ARTICLES OF INCORPORATION OF DREAM FUNDERS, INC.



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I - NAME

The name of this corporation is: DREAM FUNDERS, INC.

#### ARTICLE II . PRINCIPAL OFFICE
