The undersigned, has executed the following document as Incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as Incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

Article I – Name

The name of the corporation is:

Article II – Principal Office

The principal place of business and mailing address of this corporation shall be:

Article III – Duration

This corporation shall commence existence upon the filing of these articles of incorporation by the Department of State, State of Florida, and shall have perpetual existence.

Article IV – Purpose
