NAME

AUTHORIZED SHARES

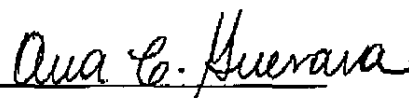

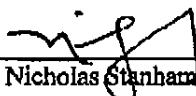
