ARTICLES OF INCORPORATION OF



The undersigned, for the purpose of forming a corporation under the Florida General, FLORIDA Corporation Act, does hereby adopt the following Articles of Incorporation Act,

ARTICLE I: NAME

The name of the corporation is Endurance Health and Wellness Inc.
