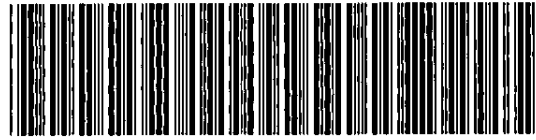

ARTICLE I

NAME

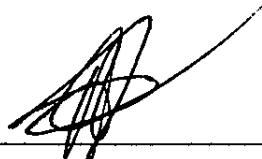


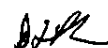
