ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is:

2. The Articles of Incorporation are hereby amended by deleting Article IV in its entirety and substituting therefor the following:

"ARTICLE IV

The Corporation is authorized to issue Twelve Million
(12,000,000) shares of common stock, par value \$1.00 per share."
