Pursuant to and in accordance with the laws of Florida, the following are the
Articles of Incorporation of Alive ALF, Corp

ARTICLE I

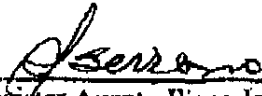

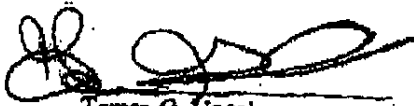

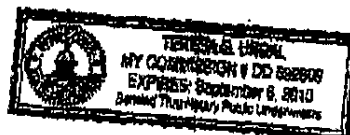
