**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purposes of forming a professional service corporation pursuant to the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is **SHACHAR PELES, M.D., P.A.** (the "Corporation").
- SECOND:** The principal office address of the Corporation is 1309 N. Flagler Drive, West Palm Beach, Florida 33401. The mailing address of the Corporation is P.O. Box 15978, West Palm Beach, Florida 33416.
- THIRD:** The Corporation is authorized to issue 1,000 shares of common stock, \$0.01 par value per share.

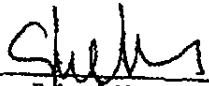
