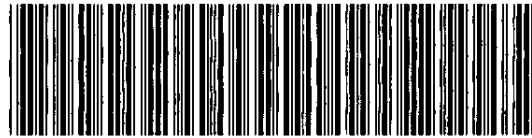

NAME

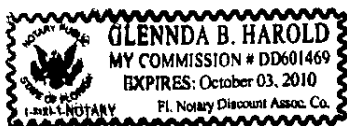

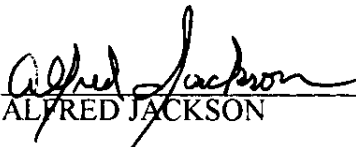

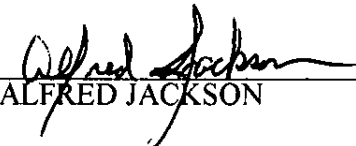
