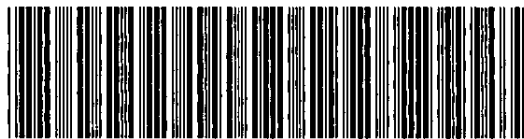

Article I

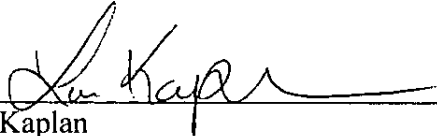
The name of the corporation shall be amended to the following new name:
