ARTICLES OF INCORPORATION OF MICHAEL S. LAQUERRE, P.A.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

$\frac{\text{ARTICLE}}{\text{Name}}$ I

Name of the corporation is MICHAEL S. LAQUERRE, P.A.

ARTICLE II Duration

The period of duration of the corporation is perpetual.

ARTICLE III Purpose

The purpose or purposes for which the corporation is organized are to engage in selling of real estate as permitted under the laws of the State of Florida.

> ARTICLE VIII Shareholder Action

Three-fourth (3/4ths) of the stockholders of the corporation shall be required for any shareholder action.

Power To Adopt, Amend, Alter, Change or Repeal Articles
The shareholders shall have the power to adopt, amend, alter, change or repeal the articles of incorporation when proposed and approved be a stockholders meeting, with not less than a three-fourths (3/4ths) vote of the common stock.

the time set for the holding of a shareholders meeting for
the election of officers that said shareholder intends to
cumulate his vote at said election.
