CHARTER

Article I

<u>Name</u>

The name of the corporation shall be ARROWHEAD CONTRACTING of SWFL, INC

Article II Principal Office

The principal place for the transaction of the corporation business shall be 709 Cape Coral Parkway West., in the City of Cape Coral, County of Lee, in the State of Florida, 33914, and the mailing address is the same.
