#### ARTICLES OF INCORPORATION

#### <u>OF</u>

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural of person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

# ARTICLE I
