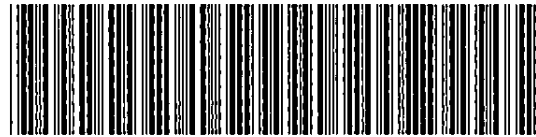

The undersigned natural person, having the capacity to contract and acting as the incorporator of a corporation under Florida Statute Chapter 607, adopts the following charter for such corporation:

**ARTICLE I**

The name of the corporation is: **Peppers 5, Inc.**




## ARTICLE IX
