THE UNDERSIGNED SUBSCRIBER to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

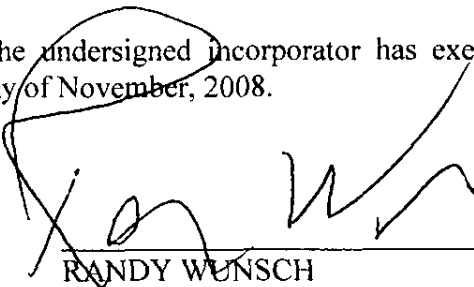
ARTICLE XII

The members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.

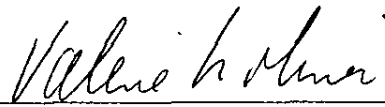
