
**ARTICLE X

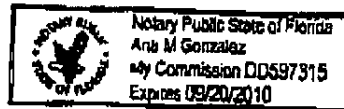


