

ARTICLES OF INCORPORATION
OF
RELIABLE HEATING & A/C, INC.

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **RELIABLE HEATING & A/C, INC.**

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.



ARTICLE TEN


The powers of the incorporators cease upon filing the Articles of Incorporation.
