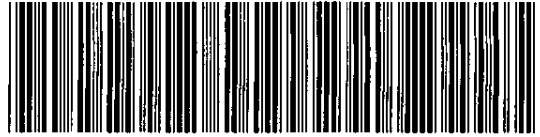

ARTICLES OF INCORPORATION
OF
SWI PUBLISHING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is SWI PUBLISHING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 500, all of which shall be common shares with par value of \$1.00 each.

ARTICLE V - DIRECTORS

The corporation shall be managed by the stockholders rather than by a Board of Directors.

ARTICLE VIII - OFFICERS




