**ARTICLES OF INCORPORATION

The undersigned, for the purpose of creating a professional service corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE ONE
CORPORATE NAME AND PRINCIPAL OFFICE**

The name of the corporation is **A. JILL RAYBURN, C.R.N.A., P.A.** ("Corporation") and its principal office and mailing address is 122 Seascape Blvd., Ariel Dunes II, Unit #202, Destin, FL 32550.

**ARTICLE TWO
NATURE OF BUSINESS**

The nature of the business to be transacted by the Corporation shall be to engage in every aspect in the practice of providing services in the area of a certified registered nurse anesthetists, and all its fields of specializations, as are engaged in by A. Jill Rayburn, C.R.N.A. The professional services rendered by the Corporation may be rendered only through its shareholders, officers, employees and agents who are duly licensed or otherwise legally authorized to render the same professional services as the Corporation under the laws of the State of Florida. The Corporation shall not engage in any business other than the rendition of certified registered nurse anesthetists services, as specified herein. However, the Corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may own or lease real and personal property necessary for the rendering of the specified professional services.

The common stock of the Corporation may not be issued to anyone other than an individual who is a duly licensed certified registered nurse anesthetists. No shareholder of the Corporation shall enter into a voting trust agreement or other type of agreement vesting any other person with the authority to exercise the voting power of any or all of his/her shares of common stock of the Corporation.

ARTICLE THREE
CAPITAL STOCK

The Corporation is authorized to issue One Thousand (1,000) shares of stock with a par value of one dollar (\$1.00) each. Such stock shall be of a single class.

ARTICLE FOUR
INCORPORATION DATE AND TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing hereof.

ARTICLE FIVE
REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The registered agent for the Corporation shall be A. JILL RAYBURN, C.R.N.A. and the initial registered office of the Corporation is 122 Seascape Blvd., Ariel Dunes II, Unit #202, Destin, FL 32550.

ARTICLE SIX
BOARD OF DIRECTORS

This Corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the Bylaws adopted by the shareholders, but shall never be less than one.
