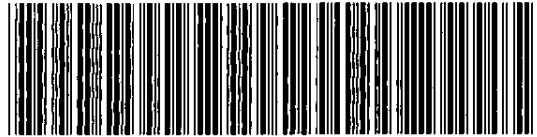

The undersigned, a duly licensed Doctor of Dentistry in the State of Florida, hereby makes, subscribes, acknowledges, and files with the Division of Corporations, Department of State of the State of Florida these articles of incorporation for the purpose of forming a Professional Service Corporation in accordance with the laws of the State of Florida.

**ARTICLE I

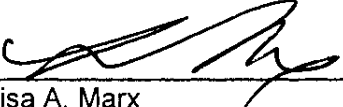
**ARTICLE IX

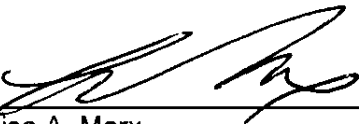
