I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and initial address of this Corporation shall be: E.A.T. AT WRC, INC., 3757 N.E. 6th Drive, Boca Raton, FL 33431, with the privilege of having its offices and branch offices at other places within or without the State of Florida.
