#### A FLORIDA PROFESSIONAL SERVICE CORPORATION

The undersigned, desiring to form a Florida Corporation under the Professional Service Corporation Act, F.S. Chapter 621, hereby adopts the following Articles of Incorporation.

#### ARTICLE I Name

The name of the corporation shall be KUTT ADVISORY GROUP, PA (the "Corporation").

## ARTICLE II Principal Place of Business

The initial place of business of the Corporation shall be 200 South Andrews Avenue, Suite 100, Fort Lauderdale, Florida 33301, in the County of Broward and State of Florida.
