ARTICLES OF INCORPORATION

The undersigned, desiring to form a Florida Corporation under the Professional Service Corporation Act, F.S. Chapter 621, hereby adopts the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation shall be KUTT ADVISORY GROUP, PA (the "Corporation").

ARTICLE II

Principal Place of Business

The initial place of business of the Corporation shall be 200 South Andrews Avenue, Suite 100, Fort Lauderdale, Florida 33301, in the County of Broward and State of Florida.

ARTICLES III

Purpose

This Corporation is formed for the purpose of engaging in the practice of law and all related services and in all businesses incidental thereto, as well as in any activity or business permitted under the laws of the Professional Service Corporation Act.

ARTICLE IV

Authorized Shares

The maximum number of shares that the Corporation is authorized to have outstanding at any time is One Thousand (1,000) Shares of common stock having a par value of One Cent (\$.01) per share. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE V
Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 200 South Andrews Avenue, Suite 100, Fort Lauderdale, Florida 33301, and the name of the Corporation's initial Registered Agent at that address is Nathan J. Kutt.

ARTICLE VI
Incorporator

The name and street address of the incorporator are: Nathan J. Kutt and 200 South Andrews Avenue, Suite 100, Fort Lauderdale, Florida 33301.

ARTICLE VII
Indemnification

The Corporation shall indemnify any Officer or Director or any former Officer or Director, to the full extent permitted by law.

ARTICLE VIII
Amendments

The Corporation reserves the right to amend, alter, change or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.

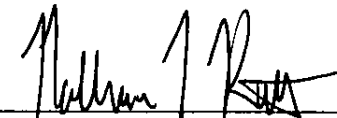
