The undersigned, acting as incorporator of Bonita Spa Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

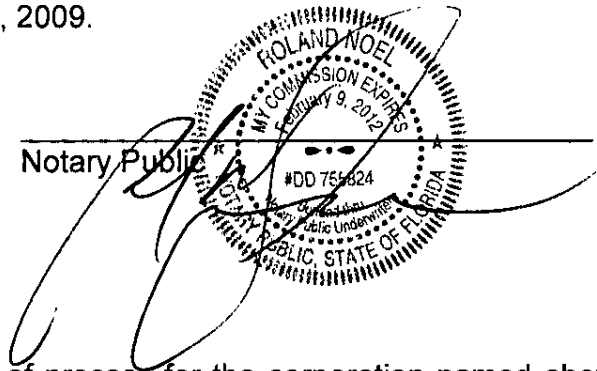
