#### ARTICLES OF INCORPORATION

**OF** 

#### SOFIESERGE, INC.

THE UNDERSIGNED do hereby associate for the purpose of forming a corporation under the laws of the State of Florida, and do hereby certify as follows:

#### **ARTICLE I - NAME**

The name of the Corporation shall be: SOFIESERGE, INC.

#### **ARTICLE II - PURPOSE**

- A. To carry on and engage in the business of the operation of a restaurant and dining facility, including but not limited to preparation of food products and beverages and delivery thereof together with any and all acts necessary and/or related thereto.
- B. To carry on and engage in any business or activity which may be authorized and permitted under and by virtue of the laws of the United States of America or the State of Florida.

#### **ARTICLE III - CAPITAL STOCK**

The corporation shall be authorized to issue capital stock in the following manner, to-wit: (1000) shares of common stock, having no par value.

#### **ARTICLE IV - POWERS**


