

OS SER 16 ARIO: 59 The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

## ARTICLE ONE

The name of the corporation is Torna Landscaping Corp

#### ARTICLE TWO

The duration of the corporation is perpetual.

# ARTICLE THREE

The general purpose for which the corporation is organized is:

- 1. To engage in the operations of landscaping and lawn maintenance service.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the forgoing or necessary or desirable in order to accomplish the foregoing.
