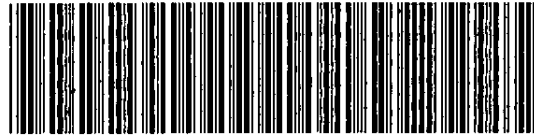


ARTICLE X.


