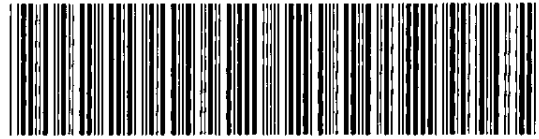

**ARTICLE I NAME**


ARTICLE XII LOST OR DESTROYED STOCK CERTIFICATE


