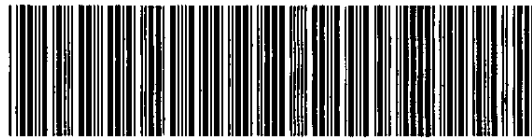

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Special Acquisitions IX, Inc. are hereby amended as follows:

**FIRST:** Article I of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be Special Acquisitions Holdings, Inc.

**SECOND:** The foregoing amendment was adopted by the holder of all the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on November 4, 2009, and the number of votes cast for the amendment was sufficient for approval by the holder of common stock.

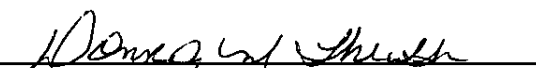
