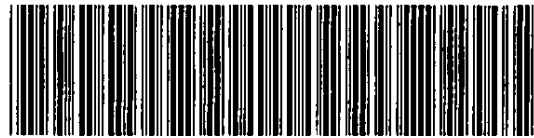



**ARTICLES OF AMENDMENT
OF
A BEKA SERVICES, INC.**

Article III of the Articles of Incorporation of A Beka Services, Inc. is hereby amended to read:

**ARTICLE III
PURPOSE**

The Blessed hope of the personal return of Jesus Christ back to earth. (Titus 2:13). The believers call is to a life of consecration which requires increasing in the knowledge of Christ and growing in grace (Colossians 1:10, II Peter 3:18, John 15:4-5). 
To do any or all of the things hereinabove set forth, and all things usual, necessary or proper in furtherance of or incidental to said purposes.




