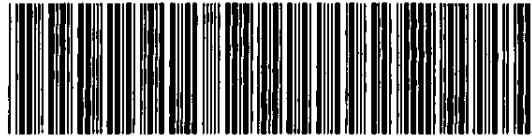

ARTICLE I – NAME

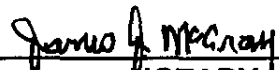

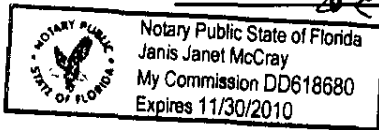
