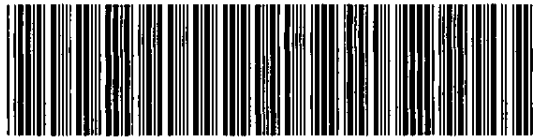


**ARTICLE X - AMENDMENT**

The Effective Date of these Articles of Incorporation shall be January 1, 2010.


