WE, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the state of Florida and, under the statute of the State of Florida providing for the formation, rights, privileges, immunities a liability of incorporating for profit it is:

ARTICLE I

The name of the corporation shall be Oil Aluminum and Iron Suppliers Corp.

ARTICLE II

The corporation shall engage in any activity or business permitted under the laws of the State of Florida and the United States of America. In particular, this corporation will engage in the exportation/importation of parts, equipment for oil companies, mining
