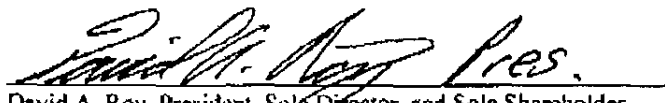
ARTICLE I
