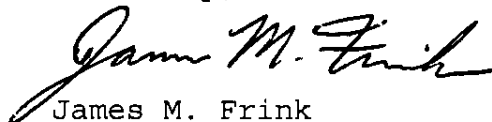

ARTICLE I. NAME

The name of this corporation is ATLANTIC HOME VALUATION, INC.

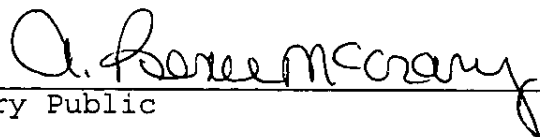

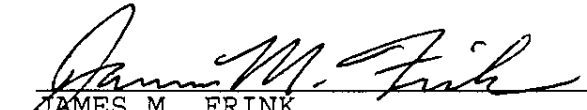
