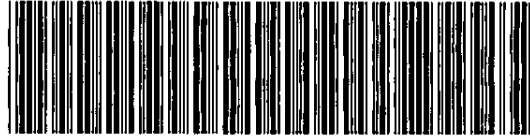

ARTICLE II – Date of Dissolution


The date dissolution was authorized: December 31, 2015.
