**ARTICLES OF INCORPORATION

I, the undersigned, make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be Computer Associates and Services, Inc

ARTICLE II

The principal place of business shall be situated at 9277 SW 146th Place, Miami, Florida 33186 and said corporation shall have the right and privilege of establishing, operating, and doing business in such other counties of the State of Florida and in such other states of the United States and Foreign countries as the Board of Directors may from time to time order and establish,

ARTICLE III

The general nature of the business to be transacted by this corporation is as follows: to render through its officers, employees and agents, who are duly licensed or otherwise legally authorized, professional, as Computer Repair Technicians and other related business services; and to engage in such other activities or business permitted under the laws of the United States and Florida for a professional corporation.

ARTICLE IV

This corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00) per value common stock. Corporate stock may be issued, subscribed or reissued in compliance with the by-laws of the corporation.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

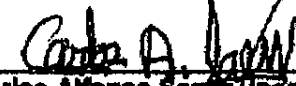
ARTICLE IX



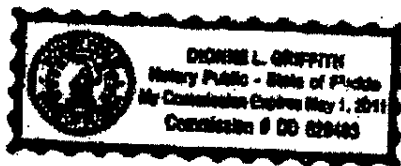
