Name and Principal Office of Corporation

Term of Corporate Existence

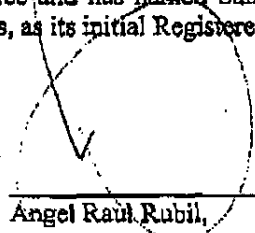

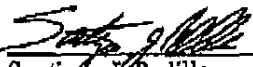

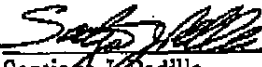
